CALL TO ORDER

Supervisor DiSalvo called the meeting to order at 6:00 P.M. and led the Pledge of Allegiance.

EXECUTIVE SESSION

A motion was made by Deputy Supervisor Don Huff and seconded by Councilmember Nate Guzzardi to enter into Executive Session. The Town Board entered Executive Session at 6:01 P.M.

A motion was made by Deputy Supervisor Don Huff and seconded by Councilmember Joseph Rawleigh to exit Executive Session. The Town Board exited Executive Session at 6:40 P.M.

AMENDED INTERMUNICIPAL AGREEMENT FOR COURT SERVICES

Following Executive Session, the Town Board considered an amendment to the Intermunicipal Agreement between the Town of Mount Morris and the Village of Mount Morris for court services.

Councilmember Karl Schrier moved the following resolution, seconded by Councilmember Joseph Rawleigh:

RESOLVED, that the Town Board hereby authorizes the Town Supervisor to enter into an Amended Intermunicipal Agreement with the Village of Mount Morris for court services, subject to attorney review and approval, upon the following general terms:

1. Monthly rent shall be established as a flat fee of \$370.00 per month, regardless of the number of times the Town uses the court facility.
2. The monthly rent shall be reduced until the amount of the Town's overpayments to the Village related to compensation for court security under the prior Intermunicipal Agreement has been resolved.
3. Separately, the Town shall release the remaining funds held in the Farm Fresh escrow account to the Village of Mount Morris, currently believed to be approximately \$2,300.00.

The Village Board also considered the amended Intermunicipal Agreement and authorized the Mayor to enter into the agreement, subject to attorney review and approval, upon the agreed terms.

A motion was made by Deputy Supervisor Don Huff and seconded by Councilmember Joseph Rawleigh to adjourn the meeting.
