HIGHWAY

Acting Highway Superintendent Smith reported the following:

- Crews addressed fallen trees, graded Swanson Road, and performed ditching work on Ridge Road.
- The Highway Department assisted Livingston County and the Town of Leicester on various projects.
- The tractor is undergoing repairs; the mower attachment is expected to arrive next month.
- The welcome sign on Route 408 requires funding for repairs.
- Stop signs within the trailer park were discussed and confirmed to be on private property, making them outside the Town's responsibility.
- The State DOT contract for Snow & Ice remains pending; there was discussion about the potential for towns to discontinue maintenance of state-owned roads.

CEMETERY

Councilmember Guzzardi reported the following:

- Inquired about the damaged cemetery headstone, which is awaiting replacement; the stone has been ordered, and the Town is awaiting delivery.
- Deputy Supervisor Huff purchased a new weed eater and two batteries for cemetery maintenance.

PLANNING & ZONING

Councilmember Rawleigh reported the following:

- The Planning Board discussed the proposed cell tower on Route 408; the public hearing remains open for written or in-person comments.
- The Town is awaiting feedback from the fire department regarding access requirements for the site.
- Code Enforcement Officer Shawn Grasby reported six active code violations. Four violation letters will be issued—two on Route 408, one on Sonyea Road, and one on Dutch Street Road. Two of the six violations have already been resolved.
